Revision Order –

Proposal of Shri Jetpur Kelavani Mandal Trust, Jetpur, Prakash Print, Near Over bridge, Navagadh Dist: Rajkot managed Shri Pranlal Chhaganlal Goda(Desai) English School, Bosamia college campus, Jetpur Dist: Rajkot of Std. 6 to 8 non-granted English medium upper primary school was rejected by District Primary Education Officer- Rajkot with order no. (3). Against this order with above reference (2) notification of R.T.E. rules 2012 rule:13(8) its appeal has been submitted by trust in this office.

As per above stated reference (4) appeal was rejected by office order dt. 21/10/2019. Against this order on Dt. 18/11/2019 and Dt. 22/11/2019, institute has submitted original land purchase document, original B.U.P. certificate, campus layout plan, Sports ground for indoor games having 981.64 Sq.mt. + 2847 Sq.mt + 875.75 Sq.mt total 4344.49 Sq.mt facilities available. Also in the property card, issued by city survey office, Jetpur Dt. 1/1/2020, the name of Jetpur Kelavani Mandal Trust has been registered as the holder of the property in the boja note.



Its copy was submitted in personal on Dt. 10/1/2020 in which total 15241.08 Sq.mt. land is shown under city survey no. 7823. Copy of land purchase document is included. School building map approved by competent authority has not been submitted as stated in the rejection order but the B.U.P. certificate issued by Chief Officer Jetpur Navagadh - Nagarpalika has submitted.

Thus rather than scrutinizing the aforesaid details and documents, the order is made to amend in reference (4) as follows:

I Dr. M I Joshi Director of Primary Education (Gujarat State) as per authority vested in me under Prologue-1, Mumbai Primary Education Act-1947 and Rules-1949 and Prologue-2, Gujarat RTE Rules 2012, Shri Jetpur Kelvani Mandal Trust, Jetpur, Near Prakash Print Over Bridge, Navagadh, Dist. Rajkot – managed Shri Pranlal Chhaganlal Goda (Desai) English School, Bosamia College Campus, Jetpur Dist: Rajkot has order to approve the proposal to start one class for non-granted private upper primary school of Std.6 to Std. 8 keeping in view the above details and documents presented.

The district Primary Education officer is directed to proceed to register this school/class as per the rules & regulations. Permission is granted on the basis of condition that school will follow RTE Rules 2012, School Safety Policy -2016 and Fee Regulation Act -2017 and obtain Fire Safety Certificate from Competent Authority.
